- 1 Tradeshow Displays International (TDI) and its subcontractors shall not be responsible for damage to uncrated or improperly packed material, or for glass breakage or concealed damage.
- 2 TDI and its subcontractors are not and cannot be responsible for loss or disappearance of the exhibitor's materials after they have been delivered to exhibitor's booth.
- TDI and its subcontractors shall not be responsible for loss, damage, theft or disappearance of materials before they are picked up from exhibitor's booth for reloading after close of show. Bills of lading covering outgoing shipments, which are submitted to TDI by exhibitors, will be checked at time of actual pickup from booth and corrections made where discrepancies exist.
- TDI and its subcontractors shall not be responsible for any loss, damage or delay due to fire, acts of God, theft, windstorm, water, vandalism, mysterious disappearance, strikes, lockouts or work stoppages for any kind, or for any cause beyond its control.
- TDI and its subcontractors shall not be held liable for any damage incurred during the handling of material requiring special equipment to properly load, unload or place, unless advance notice has been given to TDI to obtain the proper equipment.
- It is understood that TDI and its subcontractors are not insurers and that insurance, if any, shall be obtained by the exhibitor. Since it would be extremely difficult to fix the value of each shipment handled by TDI or its subcontractors, it is understood that TDI and its subcontractors do not provide for full liability should loss or damage occur. It is agreed that if TDI or its subcontractors should be found liable for loss or damage due to a failure to properly handle the exhibitor's material, the liability shall be limited to the specific article which was physically lost or damaged and such liability shall be limited to a sum equal to \$.25 per pound per article with a maximum liability of \$50.00 per item or \$1,000 per shipment whichever is less.
- TDI and its subcontractors shall not be liable to any extent whatsoever for any actual, potential or assumed loss of profits or revenues or for any collateral costs which may result from any loss or damage to an exhibitor's materials which may make it impossible or impractical to exhibit at this event.
- 8 Claims for loss or damage which are not submitted to TDI within 30 days of close of event are considered waived.
- The consignment or delivery of a shipment to TDI or its subcontractors by any exhibitor or by any shipper on behalf of the exhibitor, shall be construed as an acceptance by such exhibitor (and/or other shipper) of the terms and conditions set forth in items 1-8 above.

This authorization for material handling services contains certain limitations on Tradeshow Displays International (TDI) liability and responsibility in the event of loss of, or damage to, your materials. Please read the "Limits of Liability" page carefully.

We, the exhibitor, hereby authorize TDI to handle our shipment(s) in accordance with the information detailed in the "Shipping Instructions" information page, and in connection with such handling of our shipments, we agree as follows:

- We accept responsibility for payment of TDI's charges in connection with the handling of our shipment(s) as set forth in the "Shipping Instructions" and on the "Material Handling Order Form" and we guarantee payment to TDI in the event that any third party, acting on our behalf, shall fail to pay such charges within thirty (30) days after the close of the exhibition for which such shipment(s) is made.
- **b** We agree to the limitations of TDI's liability and responsibility as detailed on a preceding page.
- We agree, in connection with the receipt, handling, storage and reloading of our shipment(s) that TDI will provide services as our agent, and not as bailee or shipper, and that if any employee of TDI shall sign a delivery receipt, bill of lading or other document(s), TDI will do so as our agent, and we accept the responsibility thereto.
- We agree to follow all directions, procedures and guidelines established by TDI to control all traffic into and out of the site of the exhibition to prevent tie-ups at the loading platform, to keep aisles clear, and to provide orderly and efficient operation for the exhibition as a whole.
- In order to expedite removal of material from the site of the exhibition, TDI shall have the authority to hire other carriers for our shipment if the carriers originally designated do not remove our material in a timely manner. If we have made no disposition for our material, TDI shall be authorized to take our material to a warehouse to await our shipping instructions, and we agree to be responsible for charges related to delivery to, and storage and handling at, such warehouse.
- We hereby indemnify, hold harmless, and at the request of TDI, we shall defend TDI from and against any loss, cost, damage, expense, claim, demand or liability (including reasonable cost of investigation and reasonable attorney's fees) arising out of, or related to, injury to person (including death) or damage to property caused by our negligence or willful misconduct, and/or the negligence or willful misconduct of our employees, agents and/or representatives at the exhibition to which this authorization relates.
- We agree that all questions relating to classifications of our exhibit material, rates charged or weights used to determine material handling charges, shall be submitted to TDI within 30 days of receipt of invoice. Complaints received after such period shall not be considered, and payment of invoice will be made in full.
- JURISDICTION. This contract shall be construed under the laws of the state of Florida without giving effect to its conflict of laws rules. exclusive venue for all disputes arising out of or relating to this contract shall reside in a court of competent jurisdiction in Orange County, Florida.

Shipments should be addressed as shown below. **Do not ship directly to the exhibit site before the first move-in day as exhibit facilities do not handle or store exhibit material prior to installation.** The consignment or delivery of a shipment to TDI by an exhibitor or by any shipper on behalf of the exhibitor shall be construed as acceptance by the exhibitor (and/or shipper) of the terms and conditions set forth on the "Limits of Liability" information page. Questions regarding shipments should be directed to TDI. If there are any services required, and not described herein, please advise on the order form.

Common carriers do not make deliveries on Saturdays, Sundays or holidays unless special arrangements have been made. All shipments must be made on a straight bill of lading carefully prepared to show number of pieces, weight, classifications, carrier routing to show, and delivering carrier, etc. A copy of bill of lading and notice of shipments should be promptly mailed to TDI.

Drivers will be required to record their shipments at the exhibit site check-in area and will then be assigned a priority number and instructed as to the proper freight area for unloading.

Drivers of **Van shipments** will be required to submit certified weight receipts when recording their shipment at the exhibit site check-in area. TDI reserves the right to refuse to unload such shipments until a certified weight receipt is presented.

Correct weight (either certified scale or manufacturer's weights) must be provided in advance and/or at time of delivery. If not provided, receiver's estimate of weight will prevail.

Shippers must make arrangements directly with a customs broker for clearance of customs shipments. TDI will not perform customs clearance on behalf of the shipper nor serve as importer of record.

Guidlelines for Exhibitors who wish to unload their own freight from their personal vehicles

TDI claims jurisdiction over the operation of all material handling equipment, all unloading and re-loading, and handling of empty containers at the showsite.

An exhibitor may unload their personal vehicle, using only hand carts or dollies. Please follow the instructions of TDI personnel regarding where to park to unload.

No one, other than official contractor's employees, is allowed to use pallet jacks, forklifts, or other mechanical equipment. This includes, but is not limited to, I&D employees and facility employees.
